The Library Trustees and DSK, the new library architects, are just wrapping up the second phase of the design. I hope that many of you were able to join the Trustees last week when they unveiled the virtual library walkthrough showcasing the results of this effort. DSK continues to deliver on their promise to design a library that meets our needs and fits our town. We at MVLCF are proud to have funded this work to maintain momentum on the project. Library Trustees plan to complete the final phase of design and bid the project late this year and present the project to the voters next year at Town Meeting. To support them, MVLCF will be redoubling our efforts to raise funds to minimize the project's potential tax impact.

need our Mont Vernon resident donors and supporters to vote on Tuesday March 8th and join us at Town Meeting on March 9th. Not going to be in Town that week? While you do have to be present at Town Meeting to vote on Warrant Articles, it's not too late to vote absentee for elected officials. Although the Library Trustee race has two candidates for two positions, Amy White and I would still appreciate your support. The Selectmen's race offers an opportunity to support John Quinlan, our Library Building Committee chair in his mission to bring long-range capital planning back to Mont Vernon.

You can support the library project three ways at Town Meeting. The first opportunity, Warrant Article 04, also supports the new cemetery by allowing the Selectmen to construct the public access way for both projects. Warrant Articles 06 and 11 more directly support the library project. Article 6 allows the Library Trustees to use Library Capital Reserve funds and Article 11 contributes to the Library Capital Reserve. While both releasing funds from and adding funds to the Reserve may seem odd, it allows us to take advantage of the Sophia G. Daland Trust's commitment to match the addition to the Reserve.

I'm loving this new newsletter format. It will allow us to update all of you more frequently.

Thank you all so much for your continued support of both the Foundation and the Daland Memorial Library itself. Our work is only possible because of your support and vision.
